#### **Persistent Cookies**

Persistent cookies are types of cookies used to increase the functionality of the Website and to provide a faster and better service to our visitors. Such cookies are used to remember your preferences and are stored on your device via browsers.

Some types of persistent cookies can be used to provide you with special suggestions, taking into account issues such as your purpose of using the Website.

Because of persistent cookies, if you visit our Website again with the same device, it is checked whether there is a cookie created by our Website on your device and if there is, it is understood that you have visited the site before and the content to be transmitted to you is determined accordingly and thus a better service is provided to you.

#### **Customization Cookies**

Cookies used to remember users' preferences when visiting different pages of the website. For example, remembering your language preference.
